What We Do

Because of our research and development strategy we recently acquired fogging machines to make our work easy and professional. We do fall fumigation services from pest control to disease control.

WHAT IS FOGGING?

Fogging, as the term suggests, uses disinfectant sprayed from a Fogging machine to create what looks like fog in the room. It is an effective way to disinfect high levels of horizontal surfaces, hard to reach areas that are often missed or forgotten and small, and confined spaces such as extractor units. It can also be effective at disinfecting vertical surfaces.

Generally, Fogging should be viewed as an additional, belt and braces measure that is used following successful cleaning and disinfection practises. The technique should be regarded as the top-level measure for disinfection and should not be considered as a replacement for cleaning & disinfection practices.

THE BENEFITS OF FOGGING

Fogging provides the user with a range of benefits – some have been touched on but the full list includes:

- ✓ Fogging is seen as being safe and effective if carried out correctly.
- Ø Effective at reducing air-bourne contaminants.
- Effective at disinfecting hard to reach areas.
- Highly effective at disinfecting horizontal surfaces.

HOW WE CLEANING USED ROOMS

Cleaners should not enter a room for cleaning while the person in isolation or quarantine is in the room. Before entering the room for cleaning, cleaners should wait at least 30 minutes after the person in isolation or quarantine has left the room. This will ensure that any droplets have settled. Where able, windows, curtains and doors to balconies should be opened during cleaning. All areas that are normally cleaned should continue to be cleaned.

Ensure frequently handled items, such as remote controls, air conditioning controls, light switches, door handles and drawer/cupboard handles, are thoroughly cleaned. The room should be allowed to air dry before being used again. Soft furnishings, such as lounges, chairs and bedheads, should be vacuumed. If more intensive cleaning is required use steam cleaning. Linen should be bagged before being removed from the room but does not require special laundering.

PERSONAL PROTECTION EQUIPMENT

Our staff should wear the following personal protective equipment (PPE):

- Oisposable face mask (surgical mask)
- Single use latex or vinyl gloves
- **Solution** Eye protection (goggles or face shield)
- A disposable plastic apron should be used to avoid any contamination of clothes.
- The purpose of PPE is to minimise direct contact with surfaces and to protect the eyes, nose and mouth from
- splashing and dust generated while cleaning as well as from any chemicals used in the cleaning process.
